Grammar Correction

Improving/Correcting grammatical structure of a sentence so that each sentence in your dissertation is clear and makes sense.

Before Correction

To employ FDI in China, for Western Investors they would find themselves engaged an completely foreign business environment.

After Correction

~~To employ FDI in China, for Western investors~~ Western investors who employ FDI in China, they would find themselves engaged within an completely different foreign business environment

The sentence before doesn't make grammatical sense. We have simply changed the word order so that the sentence is now clear and the students' expression can now be conveyed properly.

Comment [R1]: I believe it makes more grammatical sense with the correction I inputted if this is what you are trying to say.

Spelling and Word Definition

Correction of Spellings and substituting words for others that are more appropriate

Before Correction

There is debate about if recovered and blocked memorys are real phenomenon. (Gleaves et al (2004). There is controversial about the debate because some researchers think that recovered memorys are real and other think they are not real memorys. (Eysenck and Keane(2000).

After Correction

There is debate [about if over whether](#) recover~~ed~~[ed](#) and blocked memor~~ies~~[ies](#) are real phenom~~en~~[on](#). (Gleaves et al (2004). ~~There is controversial about the debate because~~ [In fact there is fierce controversy surrounding the issue with the debate split between](#) some researchers [who theorise think](#) that recover~~ed~~[ed](#) memor~~ies~~[ies](#) are [real genuine](#) and other [researchers who theorise think that](#) they are [false not real](#) memor~~ies~~[ies](#). (Eysenck and Keane(2000).

As you can see in the paragraph above, we have corrected the spellings of words that have been spelt wrong. For example "recovered" is not spelt "recoveried". We also have replaced some words with better synonym. E.g. 'think' is being replaced by 'theorise'. We have also corrected poor wording of the paragraph and made it far more professional and readable.

Repairing Sentence

Before Correction

Is theory health state psychology can be from deal repressed memory.

After Correction

~~Is theory health state psychology can be from deal repressed memory.~~ [It is theorised that a healthy psychological state can be gained by helping people face and recover the repressed memory.](#)

As you can see, the original sentence made no sense at all. However, from the context of the rest of the essay we were able to take an educated guess at what the writer was trying to convey in the sentence. It is up to you to decide whether our interpretation is correct.

Comment [R2]: This sentence made no sense. I have changed it to what I believe you mean.

Substituting Basic for Formal Language

Sometimes when a sentence sounded too basic, the structure will be substituted in order to make it sound more professional and at an academic level.

Before:

I am good at using the Microsoft office. At the moment I am working for the Royal Bank of Scotland

After:

I am ~~competent in the use~~ ~~good at using the~~ ~~of~~ Microsoft ~~e~~Office.

~~At the moment~~ ~~Currently~~ I am working for the ~~Royal Bank of Scotland.~~

Although the sentence before is grammatically correct the language is too basic and therefore your essay may lose mark because it is not written professionally.

Correcting Punctuation

Before Correction

Shobe 1997 argued that a combination of social factors and environmental factors and genetic factors all have an influence on behaviour.

After Correction

Shobe (1997) argued that a combination of social ~~factors,~~ ~~and~~ environmental ~~factors,~~ and genetic factors all have an influence on behaviour.

Although the original sentence makes sense but there is an incorrect use of punctuation. In the above example, there were no punctuations. The sentence sounds more professional after the correction is being made

Dealing with a sentence without meanings

Before Correction

Economic recovery was the world war 2 after that suffering severe illness which bring back the office

After Correction
